TERMS AND CONDITIONS

Conditions of Eligibility

1. Subject to, and without prejudice to, all other Business Terms and Policies, the offer is available to MYFX MARKETS Clients who have satisfied the Eligibility Criteria for the offer (“Eligible Clients”) as set out in the sections following hereinafter.
2. MYFX MARKETS, at its reasonable discretion, offers the “**Celebration Bonus**” to any Client(s) it deems appropriate and for as long as MYFX MARKETS deems to provide it.
3. Only person who can form legally binding contracts under the laws applicable in their country of residence may participate in the “**Celebration Bonus**”. Without limiting the foregoing, participation in the “**Celebration Bonus**” is not allowed for persons under the age of 18 or otherwise under legal age in their country of residence (“minors”). If you are a minor, you may not participate in the “**Celebration Bonus**”.
4. The “**Celebration Bonus**” may be offered by MYFX MARKETS from time to time to clients who open real trading accounts with MYFX MARKETS, in cases where such clients are referred to MYFX MARKETS via specific websites and/or social network sites in the context of certain specific promotions, and/or surveys that MYFX MARKETS may be running from time to time on such specific websites and/or social network sites.
5. Participation of “Intermediaries/Related Parties” in the “**Celebration Bonus**” is prohibited. If the registration and/or trading data of a participant in the “**Celebration Bonus**” corresponds with the registration and/or trading information, including but not limited to IP address, of another participant in the “**Celebration Bonus**”, MYFX MARKETS reserves the right to regard this matching as a reason for immediate disqualification. For the purposes hereof, the term “Intermediary (ies)/Related Party (ies)”, when used in these Terms & Conditions, unless the context otherwise requires, shall mean to include any person or entity bearing a relationship with any participant in the “**Celebration Bonus**”, including without limitation:
 - a. Family members, such as brothers, sisters, spouses, ancestors, lineal descendants and collateral descendants;
 - b. Person or entity, whom any participant in the “**Celebration Bonus**”, directly or indirectly through one or more intermediaries, controls, or whom, directly or indirectly, through one or more intermediaries, is controlled by, or is under common control with any participant in the “**Celebration Bonus**”; for purposes of this definition, the term “control” (including, with correlative meaning, the terms “controlled by” and “under common control with”), as used with respect to any participant in the “**Celebration Bonus**”, shall mean the possession, directly or indirectly through one or more intermediaries, of the power to direct or cause the direction of management policies of such person or entity, whether through ownership of voting securities or otherwise.

Similarly, persons associated in any manner whatsoever with MYFX MARKETS and/or with the specific websites and/or social media on which MYFX MARKETS may be running from time to time certain specific promotions, contests and/or surveys, in the context of which access to the “**Celebration Bonus**” is offered, are not allowed to participate in the offer.

Celebration Bonus” Terms

1. This promotion is only eligible on valid Standard MT4 accounts.
2. Eligible Clients, who meet the criteria set forth herein are able to receive a bonus credit equal to:
 - a. A special bonus credit will be paid when each deposit amount and the minimum trading volume conditions below are met. The deposit for this promotion must be made in one transaction.

- b. In order to receive the credit bonus, all eligible customers must submit the claim form or email us at customer.service@myfxmarkets.com within 10 business days once they are qualified for the bonus credit.
3. All eligible clients are permitted to apply once for this promotion. This includes individual and company accounts.
 4. The number of volume traded can be verified by logging in to account under the “Account History” tab in terminal.
 5. The bonus credit can be used as margin, and it cannot be withdrawn nor transferred.
 6. Any profits generated from the utilisation of the “**Celebration Bonus**” are available for withdrawal or internal funds transfer.
 7. The bonus credit will expire 3 months after it’s applied to the eligible account.
 8. Clients will be disqualified if any withdrawals/funds transfers are made during the 3 months after the bonus credit was applied to the account.

General Terms

1. Please note that it may take up to 48 hours for any bonus credit to be added after an eligible customer's account has been verified that meets all of the criteria set forth herein.
2. MYFX MARKETS reserves the right, at its reasonable discretion:

MARKETS business terms and policies set forth on MYFX MARKETS website. Under no circumstances shall MYFX MARKETS be liable for any consequences of any trading cancellation or decline, including, but not limited to, order(s) closure by Stop Out.

3. MYFX MARKETS reserves the right, at its reasonable discretion, to discontinue the offering of this **“Celebration Bonus”** to any of its clients, without having to explain the reasons. Such clients will be informed via email.

4. MYFX MARKETS reserves the right to alter, amend or terminate the **“Celebration Bonus”** or any aspect of it at any time. Prior notice of such changes will be given to clients and MYFX MARKETS will post any such changes on its website. It is recommended that participants in the **“Celebration Bonus”** consult these Terms & Conditions on the MYFX MARKETS’ website regularly. Please note that taking part in the **“Celebration Bonus”** constitutes acceptance and agreement to abide by any such alterations amendments and/or changes.

Any indication or suspicion, in the company’s sole discretion, of any trading that’s against our Client Agreement including form of arbitrage (including but not limited to risk free profiting), abuse (including but not limited to participant’s trading activity patterns that indicate that the participant solely aims to benefit financially from the credit trading bonus without being genuinely interested in trading in the markets and/or taking market risk), fraud, manipulation, cash-back arbitrage connected to a trading bonus or any other forms of deceitful or fraudulent activity, will nullify all previously credited trading bonuses of the Eligible Client’s real trading account with MYFX MARKETS and/or any and all transactions carried and/or profit or losses garnered therein. In these circumstances, MYFX MARKETS reserves the right, at its sole discretion to close/suspend (either temporarily or permanently) all such Eligible Client’s real trading account(s) with MYFX MARKETS, cancel all orders and annul all profits of such participant. In these circumstances, MYFX MARKETS shall not be liable for any consequences of that trading cancellation, including, but not limited to, order(s) closure by Stop Out.

8. Any dispute or situation not covered by these terms will be resolved by MYFX MARKETS in the manner it deems to be the fairest to all concerned. That decision shall be final and/or binding on all entrants, no correspondence will be entered into.

10. If any of the **“Celebration Bonus”** terms were to be translated into a language other than English, then the English version of these terms shall prevail where there is an inconsistency.
